The Board of Commissioners of the Town of Conetoe met in a Regular Meeting on Monday, October 9th, 2023 at 6:30 p.m. in the Town Hall Council Room at 204 West Church Street, Conetoe, NC.

1. MEETING CALLED TO ORDER AND INVOCATION GIVEN

Mayor Pro-Tem Bryant called the meeting to order, and Commissioner Hinnant offered the invocation.

2. WELCOME TO CITIZENS

Mayor Pro-Tem Bryant acknowledged citizens and read through the agenda as presented. Commissioner Gray made a motion to approve the agenda and Commissioner Hinnant seconded the motion and it carried unanimously.

3. READING OF THE MINUTES

The minutes from the Regular Monthly Meeting held on September 12th, 2023 were read. Town Clerk, Kelly Hunter asked the board to consider amending the minutes to reflect a time change that was made on a Notice to the Public for the Regular Public Meeting from 6:30PM to immediately following the Public Hearing scheduled at 4:00PM. Commissioner Hinnant made a motion to approve both the minutes read and the amendment to those minutes. Commissioner Gray seconded the motion and it carried unanimously.

4. OLD BUSINESS

a. The Walk Edgecombe Event was cancelled due to inclement weather.

b. The Conetoe Clean-up will take place on Saturday, October 21, 2023. There will be another bin available to the public for this event. It will be setup at the Old Fire Department Building.

Commissioner Hinnant made a motion to approve and close the Old Business portion. Commissioner Gray seconded the motion and it carried unanimously.

5. NEW BUSINESS

a. Town Clerk, Kelly Hunter, presented the clerk report and gave an accounting of both completed and upcoming reports for the Town. Bank totals for each account were given along with a list of all bills and invoices paid and deposited for the council to review and approve.

i. Commissioner Hinnant made a motion to approve all bills and invoices paid. Commissioner Bryant seconded the motion and it carried unanimously.

b. The next Public Hearing regarding the CDBG Neighborhood Revitalization grant has been scheduled for November 6, 2023 at 4:00PM.

Commissioner Hinnant made a motion to approve and close New Business. Commissioner Bryant seconded the motion and it carried unanimously.

7. CLOSING COMMENTS FROM COUNCIL


- a. Commissioners Bryant, Hinnant, and Gray thanked everyone for coming and reminded everyone to vote next Tuesday, November 7th.
